Catalyst: Devon from Catalyst came and offered team training and coach training for the league. Also the play dates and spring clinics. They are a non profit and they are here to support us and spread the word on youth soccer. Kelly will email on D3 trainers and a coaching clinic for the fall. Tryouts for D3 conflict with the classes, Catalyst will prorate for the classes.

Earthquakes: Earthquakes are partnering with leagues for fundraising, etc. Gave a proposal for fund raising on ticket sales for the Earthquakes. The program is fairly simple and it doesn't cost the league anything. We will get back to him about the proposal. The kids would sell tickets thru their coaches, coaches will coordinate with the Earthquake coordinator, and coaches are the contact person, not the board. We would need to do \$6,500.00 which would be about 300 tickets; the league wouldn't be out any money. Fall games fill up really quick. Get the kids out to see a game that is the goal. A \$500.00 deposit is required for booking a game in the fall. We sold 126 Earthquake tickets at the discount price.
