Referee classes and August 14th scrimmages/referee on field training: It is coming together, Bob is handling the fields and teams, and Mike is handling the referees. Still working on the budget. The fields will need to be set up. Lines should be there. There are a total of 20-22 teams we need to figure out the cost. \$200.00 for full day, \$100.00 for half day, it is free to the trainees and it is mandatory for all new referees. It looks like we have three to four fields going. We may have three trainers per field may only get two per field. The cost to the teams to play the games, mid county teams kick in something and the club kicks in something. Let's just do three fields, it is easier. Games are scheduled 9-3. The games will go 9-1230 and 130-500 for the afternoon. We will have Jambi Juice that day. Club should provide water and sandwiches. Jim can fix lines if need be.

Recreational Coaches dinner at AJC on July 28th: Jim got the taco truck for the food. Mike and Barbara on vacation, napkins, plates, etc and water and soda. Food will be ready at 530. Plenty of room for

New Business:

AJC Field Configuration: We may need to get two more U10 goals about 700.00 per goal, depending on field configuration. There aren't any fields at Monterey Park that would work. We need to wait and see what the county is doing. We can chain the goals if need be, voted to buy two goals. Can we have filed 4 be an u10.

Discussion of locking AJC gate after 700pm: Mike f. thinks we can lock the gate at 700 and have a guard there at night for a week. We still have the adult's male in after us, offer to Park and recreation to help pay. Laleaga stopped practicing. Resource officer gets off at 500. The county hasn't responded yet. Bob suggested writing a letter, if we pay then it isn't okay. Table till the next meeting.
